- 1. Trafficking involves transporting people or children for forced labor, marriage, prostitution, and organ harvesting. It has many names "human trafficking," "trafficking of persons," and "modern slavery."
- 2. About 20 million to 40 million people live inside the world of modern "forced" slavery. It is difficult to detect and, unfortunately, gone undetected. Soon, enforcers will prove the UN is involved in child sex trafficking.
- 3. Child sex traffickers are very smart only about .04% of humans are caught or detected meaning that the vast majority of human trafficking cases go undetected and unpunished. Things may change soon.
- 4. Global profits of about \$150 billion a year for traffickers, \$100 billion comes directly from commercial sexual exploitation.

#### US Foster Care System is part of the Human Trafficking Crimes.

About 50% of human trafficking victims are children. This statement is hard to believe, but it is true - about **70% of these are children inside the foster care system**. Some say that in individual states, it may even be higher - 80%. Thousands of children suffer from sexual abuse within the child welfare services, especially when placed into the foster care or residential system.

Disturbing stats estimate **300,000 children** involved in underage domestic sex trafficking in the United States. This SYSTEM has failed about 200,000 to 260,000 children.

Children inside the disaster foster care system are especially vulnerable. CPS and foster care systems are not safe for children. Do not allow CPS to steal your children – do everything possible not to let this happen. Most children within the foster care system experience sexual and physical violence trauma. Children who do not have family support or relatives are easy predators, pimps, and pedophiles. Many pimps gain a young girl's attention by giving gifts and lots of attention and affection.

Many pimps are simply CON-ARTISTS. They often will act like loving boyfriends and a man who will protect and love them. They gain their trust.

#### Prostituted Children in America only.

Pimps will often demand that their sex slave bring back the money from at least 10 to 20 sex buyers per night. A young teenage sex slave can earn a pimp about \$1,000 to \$2,000 per night each.

One child sex-trafficking victim is raped by 5,000 to 6,000 SEX buyers during their lives as sex workers.

Most of these trafficked children usually only live about two years. They are either too sick or injured from the brutality to be used to the pimps. Often, the damaged children will be tossed back onto the streets. Most children usually die early or commit suicide. Many of the children have not created their natural immune system. They will get diseases like AIDS, Syphilis, and Hepatitis B. The average age for a child to enter forced prostitution is 12-14 years old, and most die within five to seven years of their first sexual act. Most of the children seldom reach adulthood.

Very intelligent sex predators are misusing the Internet daily to FIND and capture their prey. We must monitor and prevent illegal user content.

America has failed our children by not protecting them from criminal "Insider" government criminal organizations. CPS has been allowed to kidnap thousands of children from innocent families. It has all been one BIG secret about the foster care system being a sex trafficking pipeline - the facts are not only disgusting, but it must be fixed.

#### **Part Five**

### America Attempts to Stop Child Sex Trafficking in the US.



Child Sex trafficking happens all around us every day, and many people go on with their daily lives and rarely know it is happening right under their noses. Child sex trafficking occurs from coast to coast. The United States is not immune to the horrors of trafficking and commercial sexual exploitation of boys, girls, and young men and women. The most horrific stories of abuse of pimps and traffickers in our average to upper-class neighborhoods. A favorite place for child trafficking

#### Jane's story

Jane was sold to child sex buyers almost every night by her father, who happened to be a **pastor**. Jane was a sexual victim from 11 to about 14 years old. It wasn't only her. There were also 30 to 40 other girls. It was called a "Warehouse." You might assume this child SEX warehouse was in a 3rd world country; however, it was in **Portland, Oregon**. These young children were sex toys for adult men from all types of life. Some of these men were other pastures, doctors, bankers, teachers, cops, and blue-collar workers.

After being trafficked into prostitution, Jane was then trafficked into pornography until she finally escaped the sex industry life at 17.

### Fighting trafficking through texting

Disgustingly, Jane's story is one of the thousands who were sold for sex in America. Young girls are using social media, and predators find their prey right online. It's easy, peasy.

#### Sharon's story

Sharon was a runaway. Sharon ran away as a young teenager who ran away from home. Sharon was alone and afraid – living on the streets. Sleeping in alleys and under bushes. Naturally, a predator found her and promised her a better life. She began selling sex on the streets in various places. One morning, Sharon texted her father, but Sharon has not seen them in many years.

Since Sharon was a teenager, her parents remained in contact but were not aware of the tremendous hardship their daughter had lived. They had no idea their daughter had become a prostitute for many years. After talking to her parents, Sharon decided to move back home. She is rebuilding her life one day at a time.

Another runaway is **Ginger**, near Fort Worth, Texas. A pimp taught how to place ads on the Internet. "Escort" services. She met with the men for sex. Many online advertisements for "escort" services were posted. She met with strange men for "sex-dates" while the pimps stayed close to collect the payment that changed hands. Finally, in January 2013, Ginger escaped.

#### **Ginger**

"Ginger" was a victim of child sex trafficking, or "modern-day slavery," as some sometimes call it. According to the FBI, child sex abuse has been a genuine and dangerous issue in the US Thanks to the current administration; Child sex trafficking appears to be slowing down. Hundreds of pedophiles and child sex traffickers have been stopped; however, it is still a massive issue in America and worldwide.

#### Human Trafficking Activities in these States are Among the Highest in the Nation



#### **Human trafficking in America - 11 Worst States**

Most of the human trafficking victims are usually from low-income families and are children. **Almost 50% of the victims** in this crime industry are young teenagers.

**Twenty-five percent of the children** are runaways. Most of the runaways are eventually involved in sex trafficking - mostly for survival reasons. Most of the trafficking victims worldwide are and will be utilized for sexual reasons.

Eleven Countries with the Highest Rates of Human Trafficking Worldwide usually have the most problems with human trafficking. They are usually poor countries where law and order were seldom utilized.

Human trafficking victims are used in various industries, such as sex, forced labor, and agriculture, to name a few. In the United States, the primary sector which utilizes these victims is the sex industry, as the victims are often sent to brothels. Many average houses in American neighborhoods are brothels, and the neighbors seldom recognize that their neighbors are pimps and sex workers.

Some states do not have many human trafficking issues, while other countries are packed with criminals who earn billions from sex trafficking crimes. Data helps to understand which states are responsible for much of the human trafficking.

#### Michigan

#### 152 victims per 100,000 people

The sex trade is big in Michigan. The **FBI. discovered 220 cases** about sex trafficking in the state of Michigan.

#### **New York**

#### 27 victims per 100,000 people:

Because of the massive population, New York, one of the worst states for human trafficking. Human Trafficking Hotline received over 4,000 phone calls - over 1,000 cases. The state is arresting human traffickers and promising severe sentences for those convicted. Time will tell.

#### Virginia

#### 145 victims per 100,000 people

Virginia is one more major human trafficking hell hole. **Human Trafficking Hotline** received nearly 3,600 calls since 2007, while the number of victims in the same timeframe stands at 757. The majority were sex-related crimes.

Naturally, girls are the dominant sex when it comes to human trafficking victims, with 89 of the 116 victims researched being women.

### Maryland

#### 118 victims per 100,000 people:

Maryland is among the worst states for human trafficking in America, which partners with various organizations, not just combat human trafficking but also helps rehabilitate the victims.

### **New Jersey**

#### 168 Victims per 100,000 people

Human and Child **Sex trafficking is the main form of human trafficking. Authorities** recovered 82 trafficking victims.

#### **Texas**

#### 432 victims per 100,000 people

Texas is the next worst state for human trafficking. Mostly due to the southern border. In a **2011 study** reporting that over 700 girls who were minors trafficked in just 30 days. Lack of human trafficking laws have been very relaxed; however, things are changing quickly.

#### Georgia

#### 190 victims per 100,000 people

Georgia is among the worst states for human trafficking in America for child sex trafficking. Georgia has taken the issue of human trafficking very seriously. It is difficult to harness the trafficking issue.

#### Nevada

#### 122 victims per 100,000 people

Nevada is among the 11 worst states for human trafficking in America. Nevada allows prostitution in ELEVEN counties. Pimps often traffic underage children by creating false identities and confirming their presence in the sex trade.

#### Florida

#### 122 victims per 100,000 people

Sex trafficking is the most common method of trafficking in Florida. Underage girls being coerced and intimidated into prostitution.

While they were initially considered criminals, the **law in 2013** took a different view by considering them victims of sexual exploitation. This law has had a positive effect as not only are victims rehabilitated rather than being thrown into jail.

#### Ohio

#### **289** victims **per 100,000 people**

Ohio has many issues with human trafficking, with **9 out of 10 children** who run away become involved in the child sex trafficking industry. The average age is 13 years old. A task force is trying to bring awareness to more and more people.

#### California

978 victims per 100,000 people. Guess which state is the worst?

America is the worst country for buyers of Child Sex. There are eleven **states that are the worst in human trafficking.** Nearly **500,000 or more** undocumented immigrants from Mexico have been victims of labor trafficking as well.

#### Part Seven

# Many Horrific Acts You Should Know About America's Disgusting Child Sex Trade



# 1. At least One Million children or MORE in the USA disappear each year, and most were NEVER seen again.

About 200,000 or MORE children are at risk of sex abuse. Thousands of thousands are trafficked in the USA from other countries as well.

It is impossible to know precisely how many children who've been abused. Most of the children remain quiet, and thousands of victims remain silent while they are sexually victimized. Most are ashamed and live in total fear. Many children live in survival mode and lack the experience and wisdom to escape their slavery.

#### 2. The legal definition of trafficking.

The term "trafficked" means movement, transportation of victims across state or national lines. *Commercial sex acts and crimes by force, fraud, or coercion is a sex trafficking victim.* Child sex trafficking is when a person younger than 18 is trafficked for various illegal and sexual reasons.

# 3. The FBI. Defines sex trafficking as minors the fastest-growing criminal activity and the third-largest crimes besides drugs and weapons.

Why? It is a **One Hundred Billion Dollar** BUSINESS. Many young girls are sold for \$160 per hour or more. Pimps can pocket \$150,000 to \$200,000 for selling one victim for a year. The PIMP keeps all money. He gives barely enough to keep the child alive. A sex slave is forced to bring back \$500 every night. **A standard sex slave quota will make the pimp about \$14,000 per month or \$168,000 per year.** Remember, this is only ONE sex slave. What if the pimp has SIX girls or more?

#### 4. It's not just girls who are trafficked. Young boys are too.

According to the anti-trafficking organization ECPAT-USA - boys are the majority of the SEX trade. Girls usually start "the sex life" at about **12 to 14** years old; boys start younger, at **11 to 13 years old.** 



Pedophiles buy sex from boys, and most are runaways or "throwaways". Often LGBT youths are tossed out of their homes by their parents due to their sexuality. This action causes them to be vulnerable and forces them into survival mode. They are often scared and hungry. They are at high risk of being grabbed by the sex trade.

A pimp will eventually find them or a sexually another sex slave will introduce the LGBT child to the pimp. When a child or person is in survival mode, hungry and scared, they will do almost anything to remove the pain.

It is true that much of the sex trafficking industry is secret, and the exact number of boys in the sex trade is not known. We can only estimate the number of missing children being reported. The ECPAT suggested their MALE peers recruit them. From all reports, they will also experience violence associated with being a sex slave. The numbers of young boys as sex workers is more than people think – it is enormous. **Male pedophiles buy young boys for sex, who are usually sodomized.** 

# 5. Finding and sexually abusing MISSING children is EASY. Nearly all states do not collect missing persons if nobody reveals the child is missing. Most states DO NOT require Parents, Guardians or Child welfare Services to report their disappearance.

When children disappear — because of being a runaway from home, or maybe they have been kidnapped or any other reason — they sometimes fall under the radar of law enforcement. Nobody will report the child as missing. Therefore, the child is extremely vulnerable to the disgusting world of the child sex trade.

Missing children are VULNERABLE. They are usually alone, hungry, and scared. Pimps will target missing children. Easy prey. Traffickers or PIMPS know to troll shelters, bus stops, malls, and other similar locations where victims will hang out to be as safe as possible. Pimps and predators know how to spot a vulnerable child who is alone.

# 6. Unfortunately, the FOSTER CARE system has been the perfect place to traffic children.

An older man may offer a comforting position of influence, promising financial support, and an escape from an unhappy family life. Of course, it's almost always a cheap obscene con-job. Sometimes children cannot see themselves as victims.

Pedophiles are very cleaver at brainwashing, manipulation, and intimidation. Many predators will offer a FAKE sense of safety and security.

A young woman admits that she was placed in foster care 14 different times. Each time, she was raped by each foster care person. It was, therefore, easy to go from foster care to a pimp. She said, at least the pimp told me that he loved me—the foster care system as about "money" – selling children to Pedophiles.

7. PIMPS and those who run the sex trafficking organization are expert manipulators, sometimes spending weeks and months grooming girls online or in person. Pimps seek vulnerable young girls they can "groom" into being a sex worker.

By the way, pimps can be of any race. White, black, Hispanic, or Asian.

A pimp will only reveal their true intentions after the girls (child 12 to 14 yrs.) agree to leave their homes. Once the pimp has control of them, then the real-life situation begins. Young women often leave home for hopes of being comforted by an older man who will love her and keep her safe.

In a real-life story – he will teach her how to advertise herself online. The child and her pimp (boyfriend) will travel together – sometimes across the country. They meet men who will pay to have sex with her. The pimp always keeps 100% of the money.

Love — or the promise of it — can be an effective motivator.

An older man will often fool the young girl (usually a young teenager) that he is wildly in love with her. He promises her love, kindness, and gifts. He will often invite her to meet the rest of his family. They travel to another state. This removes the young girl from her family, friends, and familiar surroundings.

She becomes dependent on her "New" boyfriend (pimp) to take care of her. She trusts him. In her new surroundings, she meets other underage sex slaves or prostitutes. Then her new life begins.

#### 8. SEX. Traffickers will often place their sex slaves in dangerous situations.

Sometimes the pimp will get the young girl addicted to a specific drug. Usually, heroin or a type of opioid. Drugs help the young girl perform her sex acts easier, as it decreases her fears. She will now become a steady sex worker in order to satisfy her addiction to the drug.

If a person is an addict to a particular drug, she can easily be controlled. It is excruciating to withdraw from heroin. You can't move. You're cramped. You shake. You don't want to shower. You don't want to be touched.

**9. Real-life scenarios.** The pimp promised a 14-year-old girl a house, car, and a family. The pimp lured her to a hotel in Portland, where he beat her and later got her addicted to heroin. A 13-year-old girl coerced by her PIMP later wound up addicted to crystal meth and soon had sex with 10 to 20 men per day. Another real-life pimp met a young girl at a party. He soon introduced her to the sex trade by giving her alcohol and marijuana. Within a few days, she was having sex multiple times a day with multiple men for money. All of these young girls became good MONEY MAKERS for their pimps. E

# Traffickers USE control as their method. Intimidation of Physical Violence and many threats are all part of the abuse.

Violence inflicted by adults will have a substantial effect on a child.

Real Life scenario. A man (pimp) kidnapped to young minors in Detroit. By merely threatening the child, they can easily be forced into prostitution. He used a gun to threaten and intimidate them. He told the girls he would kill them and their families if they didn't obey him. He was a modern-day slave owner. His name is Terrence Yarbrough. He beat four young women (two minors and two adults) whom he'd forced into prostitution. The scumbag, Yarbrough, is currently serving almost 45 years in prison. A prison is a great place for him.

# 10. SEX. Traffickers have no respect for human life. They treat their sex slave like PROPERTY. Often, they are branded with tattoos. They are sold to Sexual Deviants and other Pimps.

Tatts, scarring, and burns are methods to identify a Sex trafficker's sex slave or (property).

Yarbrough "branded" all of his sex slaves by tattooing his nickname T-Rex on their arms. One girl said that she was sold, at age 14, from one man called "Love" to another PIMP called "Junior" for \$600.

#### 11. Child SEX. Traffickers are using the Internet to sell sex.

Backpage was a tabloid. 97% of the classified ads were ads soliciting child sex for pedophiles. To others, prostitution was also a big profit maker for sex traffickers. Backpage was eventually shut down.

#### Most SEX. Traffickers were likely abused and mistreated in their childhoods.

12. The Pimps hold this law over the heads of their sex slaves. Under most current state laws, children who are forced into prostitution are subject to criminal prosecution. Pimps will threaten their sex slaves with this law. Pimps will make the child sex slaves believe that they can be prosecuted for selling sex. The Federal law states that anyone under 18 caught in the commercial sex trade is considered a trafficking victim. State and local laws will vary from state to state.

Most states will make child sex for money a criminal activity, meaning that a person under 18 attempting to solicit sex on FOR the pimp may be formally arrested for child prostitution - even though the child is under the legal age. Children may be detained or even arrested by law enforcement for merely trying to escape an abusive living arrangement. Please research or consult with a professional for legal advice in your area. Police may charge a minor (child) with a status offense for various reasons instead of taking action against the pimp or seeking the REASON the child became a sex worker.

This helps create a continuous cycle of sex abuse. There are more animal shelters (5,000) than there are beds for sexually abused children living on the streets.

#### 13. The "johns," or customers, usually walk away without any type of punishment.

Most BUYERS who commit child rape are not accountable for their crimes.

#### 14. New legislation May Stop all of these Crimes against Child Sex.

The Polaris Project defines Safe Harbor laws that were passed in 12 states. It will protect minors (young teenage girls and boys) from prostitution charges *and* offer rehabilitation services.

\*\*\*\*\*\* \*\* Federal Bill will require parents and those taking care of children to report missing children within 24 hours of the disappearance. And here is a federal bill, the Justice for Victims of Trafficking Act. The mission is to decrease the demand for child sex trafficking by encouraging the FBI. and the police to prosecute the BUYERS of child sex. \*\*\*\*\*\*\*

#### Interview with a Sex Trafficking Victim

Experts who study and research the child sex slave trade say this story stretches across the globe. President Donald Trump is dedicated to hunting down human traffickers and those involved in sex slavery.



The victim, "Chris," said that she was sold to her "sex slave owner" by her parents when she was first BORN. She was born into the disgusting world of sex slavery. It was the only life she knew. ### Part Eight

#### Is it possible CPS set up a system to steal and SEX. traffic Children?

Many people DO NOT want to hear the ugly truth about sex trafficking – most Americans are simply unaware of how child sex trafficking works or how popular it is among thousands of sadistic PEDOPHILES.

Thousands of young Americans are victims of sex trafficking. Where are they abused? In our nation's FOSTER CARE system. That's right. It's a deeply "EVIL" system that leaves thousands of children vulnerable to (CPS) pimps grooming them for the illegal sex trade. The real facts are; our nation's foster care system is a criminal organization for buyers of children.

Some of the FBI's good guys are finding hundreds of children being trafficked into the foster care system. Yes, many foster homes get paid to be guardians of children – however, many are PEDOPHILES!

Beware of CPS when they attempt to steal your children because of the Covid virus. If one or both parents test positive for Covid, then CPS will most likely remove the children from the home. It will not benefit you or any family member to test for the Covid virus. You should stay out of the health system. You must fight this law. Save the Children.

Amber alert is not what you think. It's actually an alert saying that CPS has stolen another child.

Connecticut, the "good" police rescued nearly 100 CHILDREN from sex trafficking; almost all were from the child welfare system. The FBI discovered that many foster children found in the hands of sex traffickers, including children as young as eleven, were never reported missing by child welfare authorities.

They are sexually abused inside adoptive homes, or in one instance, reportedly raped inside a child welfare office.

#### All 50 states have similar issues with missing children.

#### Georgia Senator Nancy Schaefer

Georgia Senator Nancy Schaefer, who was murdered, wrote extensively on the **CPS abuse and corruption** and fought hard. Simultaneously, she was alive to bring awareness to sex trafficking happening through corrupt government institutions. **Nancy was, unfortunately, murdered.** 

# Senator Nancy Schaefer was a significant voice against CPS and discovered many cases of abuse until she was murdered.

The CORRUPT news coverage of her death never even mentioned her life's work. The Senator outlined the corruption of the child welfare organization, which in many instances, forcibly remove children from some so-called-imperfect and often poor but loving homes in exchange for federal dollars.

Nancy Schaefer was the author or an extensive report to the Georgia Assembly that detailed the abuses she uncovered:

This report, Child Protective Services nationwide, is a CORRUPT and ruthless system, and it is broken and nearly impossible to be repaired. All parents and families should be warned about the dangers of child sex trafficking.

CPS, known as the Service (DFCS) in Georgia and other titles, has become a "protected empire" built on taking children and separating families. This report is concerned with "legal kidnapping" and DFCS, who does not remove children when a child is an enduring torment and abuse.

Some of the worst information she revealed included that **CPS** is a for-profit business that depends on removing **children** for **MONEY**.

The Adoption and the Safe Families Act by President Bill Clinton. He offered **cash** "**bonuses**" to the states for every child they adopted out of foster care. ALWAYS NEEDS MORE CHILDREN. CPS is a corrupt organization.



Buyers of children like a wide choice of children. So, CPS makes sure to have a good variety of children. Some counties may provide a \$4,000 bonus for each child adopted and an EXTRA \$2,000 for a "special needs" child. Employees of CPS work to keep the cash flowing. The lower level minions of CPS may not know about the TRUE nature of CPS and its mission. Some actually "think" they are protecting children, when they are even feeding a very evil and corrupt system.

- The CORRUPT funding continues as long as the child is GONE from the original house. When a child is inserted into foster care, a new pedophile person(s) the "adoption bonus funds" are provided. Naturally, it is not uncommon for children to be emotionally distraught by being legally kidnapped and placed in the hands of pedophiles; they often require medication to keep them sane.
- Here is the sickness to it all. There is no financial resources and no real desire to unite a family and help keep them together at this time. The reason is unknown for now.

**CPS** is a traditional and great method for child sex abusers to find a massive groups of innocent children to prey on? Almost all foster children are now considered at "high risk" for abuse. Meanwhile, the real and loving biological parents are prevented by illegal court orders from talking to the press about having their children - who are unfairly removed from them and put into a system set up to abuse them sexually. **Can you believe this?** 

Many corrupt judges are also "Pedophiles." Thousands of parents report to *Medical Kidnap*. This illegal gag orders imposed upon them by judges who claim to want "privacy for the child." This is the highly sneaky way the STATE will silence the w.histleblowing parents. Thousands of dangerous pedophiles have admitted to searching foster care sites to find children to sexually abuse.

This is an online website named Adopt Us Kids, where children's photographs are posted from every state with personal information about the children. This ad from the Adoption Profile Exchange is dangerously disgusting — it appears to be like a commercial ad for *a child searching for her next abuser*.

**EXAMPLE – REAL AD:** Please meet Janice. A beautiful and intelligent young girl. She loves to keep everyone entertained! Janice is a real **people pleaser** and loves to hear the words "well done." Janice will do her very best as the youngest child in a family. Janice needs loving care as she had the **effects of trauma.** 

The parents are often forced to watch as their child(s) are adopted out to others through websites. Most of these children's lives will never be the same again.

**Make a note of this too.** Most of these INNOCENT parents have NOT been charged with a crime, NEVER spent one day in criminal court, and THESE parents had their rights DELETED by a PEDOPHILE LOVING judge. Not only that, but **grandparents** are regularly denied custody in favor of strangers. It has been determined that many judges ALSO receive cash kickbacks from the state for deleting the rights of parents.

Why is this allowed? Why and HOW can children be removed from parents without warrants? Trials or by a jury in criminal court? Can this happen in America?

You bet it can! - "family court corruption." You will receive plenty of results concerning the disgusting and tragic stories of parents denied due process. Where are the screams of outcry?

There are plenty of reports concerning foster care abuse. A Texas CPS caseworker was arrested for soliciting sex with a minor. She was selling them for sex over and over for decades!

Perhaps they're nervous they'll wind up just like her if they expose this billion-dollar industry. Why isn't CPS being investigated? So far, NOTHING!

#### **Part Nine**

#### **Child Sex Rings**



The term CHILD SEX RING is often defined as one or more sex offenders who simultaneously are involved sexually with several child victims. In other words, children are being raped and passed around.

Children do not need to be purchased. The mere fact, the child or children have been sexually abused by others.

It does not mean group sex.

Several men rape many young girls at one time, and in some cases, however, the child is mostly raped by one man at a time. In a child sex ring, the offender often has sex with other children before walking away from the children of a particular child trafficking ring.

The various child sex slave knows other children are being sexually abused during a specific period. They may even know each other.

Some children might believe that 'THEY" are the only ones having a "special" relationship with the SEX offender or child rapist. Other victims may observe other sexual activities of the serial child rapist with other children. Some SEX criminals may treat some victims differently than others.

Many of the **experts** have little or no experience dealing with child sex rings. All or most of their experience is with one-on-one interfamilial incest cases. This has been the past – however, they are quickly learning about the hundreds of pedophile sex rings in America alone.

It is a worldwide pedophile industry.

**Multiple Sexual Child Abusers.** Sexual offenders or abusers like to communicate with each other and trade information, experiences, and photos with each Offender interaction is essential in investigating these cases.

Discovering multiple abusers' existence can be challenging to investigate, but it can be a great benefit. The more the abusers are involved, the greater the odds that they will make a MISTAKE, and their error can be used to provide the necessary and alleged abuse.

**Gender of the Victim.** This can be a big difference between interfamilial and sex ring cases. Unlike interfamilial sexual abuse - the most commonly reported sexual abuse case is a young female; in child sex rings, the victims are usually **adolescent boys.** 

**Types of Child Sex Rings.** Evaluating and analyzing child sex ring cases is important. There are several types of rings. "traditional" or "ritualistic" or "satanic" child sexual abuse and children sold for sex.

**A syndicated ring**: A commercial and well-organized group of individuals will recruit children, produces pornography, delivers direct sexual services, and establishes a massive list of customers of SEX BUYERS.

A child sex ring can involve a daycare center, a school, a scout troop, a Little League team, or neighborhood children. It may also involve marriage as a means to access children.

**Male Sex Abusers or Offenders.** Ninety-five percent or more of the child sexual abusers' offenders are MEN. When a female sexual abuser is involved, she will usually have one or more male sexual criminals who will accompany her.

**Preferential Molesters.** Most of the SEXUAL ABUSERS of children are offenders who are pedophiles. Their sexual preference is children. Some homosexual pedophile men are sexually attracted to young adolescent boys. These types of men are usually the most persistent and consistent child abusers.

**Child Sex Abusers** will easily create hundreds of child victims in a lifetime. They usually begin their sexually criminal behavior when they were teenagers and will continue their sexual abuse on children as long as they can. Pedophiles are generally very "nice" men and women. After all, this is their lure to attract children.

Pedophiles almost always create a method to have easy access to children (marriage, neighborhood, occupation).

It should be clear that every person who is in the care of your child be vetted. Just because a child sex abuser is a doctor, priest, minister, or therapist, for example, does not mean that he/she is safe and NOT also a pedophile sexual abuser. A predator may have a long history of sexual abuse and be part of a long-term persistent lifestyle.

A pedophile, during their life, will leave behind a list of child victims. The children must endure the emotional pain all their lives. Usually, one way to convict a pedophile is the evidence he owns—usually children pornography.

Naturally, it is best to get a preferential child sex abuser's conviction based on past actions. If, however, all else fails, a sexual predator can be convicted in the future based on children's abuses.

Most child sex abusers spend their entire lives attempting to convince themselves and others that they are NOT perverts. Pedophiles will often proclaim their innocence up until the day they are convicted. Their argument is this is what I get for 'loving children?"



The main thing of preferential child sex abusers is multiple child victims, continued access to children, and child pornography collection. 66% or more of the victims are young males. Most of these males are boys between the ages of 10 and 16.

**Sexual Motivation.** A child sex abuser frequently claims that sex is only a small part of their "love" for children; the **fact** is that when the sexual attraction is gone, the relationship is over. Their primary reason for a pedophile to communicate or interact with a child is for SEX.

**Child Pornography and Child Erotica.** Most child sex abusers almost always own an extensive collection of child pornography and or child erotica. Child pornography is often defined as the sexually explicit visual pics of a child, including sexually explicit pictures, magazines, movies, or videotapes. Child erotica (pedophile paraphernalia) is usually defined as any material relating to children, which serves a sexual purpose.

## Control of the child is the most crucial ingredient of the child sex abuse RING.

Creating a network of pedophiles and multiple sex partners for a stable of young children is extremely important. Then the pimp must make sure there is no evidence of the illegal actions.

A PIMP or child sex slave owner must be experienced in the manipulation of children. What motivates children to do actions beyond their own needs or interest? As stated above, control is primarily maintained through attention, affection, and gifts are all parts of the grooming process.

Pedophile child sex abusers seduce children the same way that adults attract one another. The big difference is between the adult authority of the child abuser and the child victim's vulnerability.

#### Part Ten

#### Here are Few Signs of Child SEX. Trafficking in Neighborhoods.



It is extremely difficult to recognize a house set up for child sex. Nearly all of these child sex "houses" go undetected. People in neighborhoods seldom get to know their neighbors and rarely pay attention to what is happening right under their noses. American humans are trafficked in and out of rented or owned homes for labor and SEX. every day. Much of this ILLEGAL activity goes undetected in friendly neighborhoods. These are all criminals who appear to be living average lives.

Human trafficking isn't ONLY an issue in 3rd world countries. There literally thousands of SEX brothels (sex for sale) right in the best neighborhoods in the United States. They are incredibly prevalent. The house is maintained with a nice clean appearance – the outside of the house is also maintained, and the yard is well manicured. They make sure no attention is brought to the place. Most of the sexual activity might be inside the house. Buyers of sex arrive throughout the day or all through the night. Neighbors seldom notice because most of the neighbors are at work during the day, and most neighbors are asleep at night.

Most people who BUY sex often look like you, or they look like your neighbors.

#### Signs of human trafficking

Below are a few red flags; the house might be a house for human traffickers.

- Unusually high numbers of people coming in and out
- Interior locks on doors or windows.
- You're usually not invited inside or NOT permitted inside the house.
- Visitors to the house who lack knowledge of the neighborhood
- Look for those who seldom leave the house. Human trafficking victims rarely leave home.
- Children at home, but do not appear to be homeschooled.
- The house owner or person leasing the house will usually NEVER look at you in the eyes. Eye contact or seems overly anxious.
- Look for expensive gifts.
- Loo for lies or storytelling.
- Someone who appears to be a family member but is dressed very differently or has a significantly lower level of hygiene than the rest of the household.

#### What to do if you suspect human trafficking

You should report human trafficking anytime you suspect it. You can do it all anonymously to the National Human Trafficking Resource Center Hotline at 1-888-373-7888. This may bring it to the attention of the FBI. The field office in the appropriate jurisdiction and police who are trained at identifying human trafficking.

#### Part Eleven

Children Are bought and sold for SEX. These are the Hidden Victims of the Open Border Situation. We must close the borders soon.



United States-Mexico border helped define the true victims. Children are being bought and sold to Americans for SEX. Hidden is a much uglier issue. Children are smuggled across our SOUTHERN BORDER ARE BOUGHT AND SOLD FOR SEX.

There are **34,000 to 60,000** and more sex-trafficking cases (these are only reported cases). About 1,000 or MORE of the cases annually involved foreign nationals smuggling men, women, and children across our southern border.

Central American and Mexican Drug cartels control the multi-billion-dollar sex trade crossing the southern U.S.-Mexico border.

The groups were smuggling young girls from Mexico and Central America and forced them into the sex trade.

As young as 11 years old, women and girls were coerced or abducted and then smuggled through the US-Mexico border to SELL sex acts to willing buyers. Some child sex victims are forced into sex as many as 45 to 60 times every day. These women and girls DO NOT enter into the sex trade as volunteers; they are often sold or kidnapped and tossed into the sex trade. They are often beaten into submission, sexual assaults, and physical threats are usually made concerning their family members IF they do not do as told.

We should ALL take part in protecting the innocent young men, women, and children crossing our southern border. These young children's bodies are being bought and sold and are part of the modern-day sex slave trade.

Pimps and child sex buyers have turned young boys and children into victims. They are forcibly transferred into the United States across our southern border and organized – they are bought and sold for SEX. and forced labor. President Trump has signed anti-trafficking legislation focused on the child sex trade.

- The Abolish Human Trafficking Act provides many resources for human trafficking victims and human sex
- The Frederick Douglass Trafficking Victims Prevention and Protection Reauthorization Act authorized \$430 million to fight sex and labor trafficking.
- The Stop Enabling, Sex Traffickers Act
- The Trafficking Victims Protection Act regulations on countries that fail to help end human trafficking. However, one piece of legislation with no enforcement trigger is insufficient.

Thankfully, the Trump administration has increased resources necessary for law enforcement to fight HUMAN traffickers. Still, more is needed to combat trafficking and the cartels who are pouring into our nation. The traffickers are giving pedophiles an unlimited supply of children to prey on.

Naturally, children who come from Mexico alone without an adult are especially vulnerable to human trafficking.

Once they are manipulated or coerced by drug cartels and local gangs to serve as their drug mules, then these same children are organized - bought and sold for SEX. in the United States.

Many migrant children coming across the US border from other countries, who appear at our southern border, are vetted. They are immediately inserted with the Office of Refugee Resettlement to either enter **foster care** or be reunited with family members who legally live within America.

When the US creates an adequate system for seeking out and vetting immigrants, then the U.S.-Mexico border wall is the only way to put a dent in the sex-trafficking industry. Many of these young children, especially those from Mexico, are returned to their country on the same day if there is no trafficking connected to them.

Busting the traffickers at the U.S.-Mexico border is the only way to combat the international cartels who are smuggling child sex workers across our border.

Innocent children crossing our southern border are bought and sold into the modern-day SEX trade.

What should we do about it?

Jimmy Savile got away with abusing at least 500 children and sex with their dead bodies.



Jimmy Savile was an ugly unkempt man. The hook nose, the jagged-tooth grin, the big bugged-eye balls are many of his gross characteristics. He had platinum hair. A fat cigar nearly always in his mouth. He seemed to talk exclusively in catchphrases.

#### The kids liked his jokes. Savile was very popular.

Savile was great friends with the royal family. He spent holidays with the Thatcher's and was knighted by Queen Elizabeth and Pope John Paull II. His weirdness is apparent now. Why couldn't people see it then?

He brought in or funded \$5.2 million for a hospital in Leeds, one of the most extensive.

Rumors and Whispers began that he was a sexual predator and had abused hundreds of children. But hardly anyone believed the stories. On October 29, 2011, Savile died at his home in Leeds.



#### The rumors were true.

Savile was a very dangerous and prolific pedophile. The health service investigation confirmed his actions. He never stopped, and his actions injured hundreds of innocent children.

Savile sexually abused at least **500 girls and boys.** Many children were very young. Some children that Saville abused were as young as two years old. However, Saville's favorite ages for sexually abusing children between 13 to 15. However, he would sexually abuse most age people - even older adults up to about 75 years old. Saville had total access to Leeds General Infirmary. Saville raped and sexually abused boys, girls, men, and women anywhere he could. He also had sex with dead bodies, and even told **several hospital workers** that he created homemade jewelry from a gentleman's glass eyeball.

Saville got away with all his disgusting episodes for decades without any ramifications. No punishment whatsoever. Many people believe Saville went unscathed because he was best friends with the Royals, Prince Charles, and the Queen.



## How is this possible? How did Savile Continue his Horrific Sexual Actions for Decades?

Some say that he was permitted to perpetuate his sexual deviance because he was Jimmy Savile and was raising millions of dollars are children charities. He had celebrity status.



One woman remembered Savile had sexually assaulted her when she was 16. Even several decades later, she told investigators she remembered it like it was yesterday. After he was finished his sex act, he threatened her not to talk about it. Savile said, "nobody would believe you." The girl told her mother, but her mom didn't believe her. The girl never spoke about the incident again.

Experts have examined Savile's actions since his death. They say it he had mania, dissociation with his victims, and split personalities. Some call it the "dark triad of personality characteristics." Psychologists said that Savile was a psychopath. Machiavellianism and narcissism. Such people often slide easily between personas. Savile had a grandiose of self.

Thousands of children are stolen from neighborhoods, homes, low-income families, poor countries, even hospitals. Some children are even sold. Child sex trafficking is more prevalent today than ever before.

Experts say that an adult pedophile will sexually abuse 150 to 300 children before or if he/she is caught.

Often, children are placed in foster care situations by CPS It has been alleged that CPS higher management is in the child selling business and has allegedly stolen and removed children and planted the children in fake "foster" care homes. Many of these foster care people are pedophiles. CPS alone, from their data, say that they remove about 250,000 or more children per year – the number of children who return home is not known.

- About Two-thirds of sex offenders in state prisons committed offenses against children.
- There are more than 747,000 registered sex offenders in the United States today. As many as 100,000 are noncompliant and missing.
- The U.S. Justice Department estimates that close to 300,000 American youth are currently becoming commercial sexual exploitation victims.
- Data suggests at least ONE HUNDRED THOUSAND American children a year are victimized through child sexual ABUSE. This number is much more than those children who die in car accidents. Or illegal drugs combined!

According to crime reports, "the prevalence of child sexual abuse is usually not reported." On average, 69 out of 100 child sex abuse actions go unreported. Out of every 100 sexual assaults, only 31 are reported to law enforcement.

- During one year in the US, 16 percent of youth ages 14 to 17 had been sexually victimized.
- Throughout their lifetime, 28 percent of US youth ages 14 to 17 ARE sexually victimized.
- One in TWENTY-FIVE children between the ages of TEN and SEVENTEEN has received an online sexual solicitation from someone who tried to contact them offline.

**Warning:** Pedophiles are now targeting underage children from 12 to about 15 by using their INFO from twitter, social Facebook, and other social media accounts. Pedophiles discover the child's likes and dislikes, where they live, where they go to school, and their current location. Pedophiles have raped thousands of underage victims just by luring them from social media profiles.

Mental health experts say that when a man becomes addicted to child pornography, he will almost always progress to children much younger and try to find more sadistic, masochistic images and sex with animals.

A pedophile will usually abuse children until he can be arrested, in prison, or dead. Statistics show pedophiles will have a lifetime of victims – hundreds of children.

## Who They Victimize



Pedophiles often have their favorites. They will seek out particular characteristics and appearance in their potential child abuse victims.

Pedophiles often see children from where there is a divorce. A woman who is working and raising a child on her own is a target. Why? Because the children are more prone to being lonely, alone and lack the feeling of being loved.

A strong family unit is essential when raising a child. A mother and father who showers the child with attention and love is the foundation that provides a safety net for the child. A married mother and father are a protective shield for the child.

Without this healthy ingredient, the child may have many psychological and emotional issues. The pedophiles will use these issues to his/her advantage.

Children living without parents are TEN TIMES more likely to be sexually abused than children who grow up with a healthy married mother and father who love them. Children who live with a single parent with a **live-in partner** are at the highest risk: The child is twenty times more likely to be victims of child sexual abuse than children living with both biological parents.

According to the 2014 Pew Research statistics, more than half of American children today (54 percent) live in NON-traditional families — *broken* families. Thirty-four percent live with a single parent.

Pedophilia is INCREASING, and fathers are NOT at home to STOP it. Many fathers are not protecting their children.

Over a million children each year are more or less thrown to the wolves. More and more children are becoming available for prey for PEDOPHILES. The supply for children is increasing, and thousands of pedophiles are in hog-heaven.

Ninety percent of both child males and females with mental or physical disabilities will be sexually harmed at some point in their lives, and 49 percent will experience ten or more abuse incidents.

Hopefully, if enough of the public becomes aware of these satanic pedophile criminals, maybe we can save MORE children's lives. The current administration has been recovering many hiding places of 'live' children, and thousands of pedophiles found inside cages where they belong. The media seldom broadcasts these successes.

Many catholic priests are guilty of child sex abuse or pedophilia. The organization even has a cover-up method they use to protect guilty priests who engave in pedophilia.

Church authorities followed a "playbook for hiding the truth," the reports states. The patterns were comparable enough that FBI analyzes of the church's reactions yielded 7

guidelines, essentially, an institutional guide to concealing abuse. Here are 7 cover-up methods.

- Make sure to use euphemisms rather than real words to describe the sexual assaults in diocese documents. Never say"rape"; say "inappropriate contact" or "boundary issues."
- Don't conduct genuine investigations with properly trained personnel. Instead, assign fellow clergy members to ask inadequate questions and then make credibility determinations about the colleagues with whom they live and work.
- For an appearance of integrity, send priests for "evaluation" at church-run psychiatric treatment centers. Allow these experts to "diagnose" whether the priest was a pedophile, based largely on the priest's "self-reports" and regardless of whether the priest had actually engaged in sexual contact with a child.
- When a priest does have to be removed, don't say why. Tell his parishioners that he is on "sick leave," or suffering from "nervous exhaustion." Or say nothing at all
- Even if a priest is raping children, keep providing him housing and living expenses, although he may be using these resources to facilitate more sexual assaults.
- If a predator's conduct becomes known to the community, don't remove him from the priesthood to ensure that no more children will be victimized. Instead, transfer him to a new location where no one will know he is a child abuser.
- Finally, and above all, don't tell the police. Child sexual abuse, even short of actual penetration, is and has for all relevant times been a crime. But don't treat it that way; handle it like a personnel matter, "in house."

It's a big "dirty" club, and if you're not a psychopathic pedophile-you're not in the club. These are a few of the professions psychopathic pedophiles seek out.

## What is Adrenochrome? The Killing of Children?
